#### **Alumni Club Members**

The personal data we collected during registration for the Alumni Club is used for these purposes:

- 1. for member administration including regulars' table management and statistical evaluations,
- 2. to administer the parking entitlement associated with the club card at Campus Krems, as well as



3. to prepare, conduct and follow up events and/or competitions and the cooperation with event partners associated therewith on a case-by-case basis, given your participation.

Legal basis: Art. 6 para. 1 lit b GDPR

Non-provision of this data is an obstacle to membership in the Alumni Club.

**Storage period:** We store your p data until the termination of membership or within the framework of events or competitions up to a maximum of 4 years thereafter or until the expiry of any statutory storage periods (according to the Austrian Commercial Code UGB).

**Recipients:** We will pass on your p data to the staff of the regulars' tables, the FM Plus for the allocation of parking permits and to the cooperation partners of our events listed in the invitation if necessary within the framework of the organization.

P data of the prize winners of our competitions may be passed on to the sponsors of prizes on a case-by-case basis, e.g. to redeem free tickets.
