1. Strategic approach

"Focused Expansion of international activities" is one key strategy of the University for Continuing Education Krems (Danube University Krems). This document presents this concrete key strategy and thus supports the strategic goals of the university:

- Leading university for continuing education in Europe
- High quality
- Active cooperation partner for academic and extra-university institutions
- Well-developed research with a clear profile
- Intensified research-driven teaching
- Good balance between study, work and family
- Higher percentage of women in leadership positions.

The University for Continuing Education Krems is the leading **public university** for **continuing education** in Europe. With its expertise in teaching and research it works to overcome **societal challenges**.

KEY PRINCIPLES





1.1 NATIONAL AND REGIONAL

In 2020, the National Mobility and Internationalisation Strategy for Higher Education 2020-2030 titled "There are many routes to internationalisation"¹ was developed in Austria in dialogue with and with the involvement of the higher education land-scape. The strategic goals "Promote an all-encompassing culture of internationalisation at higher education institutions", "Promote mobility for all members of higher education institutions", "Develop and implement innovative digital forms of mobility", "Effective skills improvement and institutional learning" and "Global Mindset – Austria's higher education institutions and their position in the world" are, in part, already being implemented at the University for Continuing Education Krems and are addressed for further development in the current key strategy "Focused expansion of international activities".

Within the "Austrian University Development Plan 2022-2027"² which attends to the transregionally coordinated and regionally distributed range of services offered by Austrian universities, system objective number 6 specifies the prioritization of the enhancement of internationalization and mobility as a goal for the further development of universities throughout Austria. With the current key strategy, the University for Continuing Education Krems is committed to the measures contained therein: to increase high-quality transnational and physical mobility as an integral part of an "internationalized curriculum", to internationalize studies and teaching and to generally promote internationalization. Regionally, the university is an institutional member of the "Danube Rectors' Conference."³ Not only for this reason the Danube region and its extension, the Danube-Moldova region, are central fields of action for the university. As the only public university in Lower Austria, the University for Continuing Education Krems contributes to the region and its development on a societal level. Topics such as new types of employment, societal trends, migration, civic engagement, etc., must be researched and taught in cooperation with neighboring countries in order to ensure high-quality research and teaching at an international level. This also serves to counteract brain drain, a challenge for the region. Considering this context, the strategic objectives of the action plan "EU Strategy for the Danube Region",⁴ in particular priority areas 7 (Knowledge Society), 9 (People and Skills) and 10 (Institutional Capacity and Cooperation), are already being implemented at the university and addressed in the current key strategy in order to be further developed.

1.2 EUROPE

In the European context, the University for Continuing Education Krems is committed to the documents and objectives of the European Higher Education Area with a special focus on lifelong learning, an essential element since the 2001 Prague Conference, a periodic and itinerant ministerial conference that evaluates the progress made and decides on new steps within the European Higher Education Area.⁵ The "European Strategy for Universities"⁶ published in 2022 addresses the topic of lifelong learning in more detail and in light of current events and notes the following:

"Universities have a key role to play in preventing skills mismatches and bottlenecks that risk hindering Europe's recovery, and in enabling the development of learners as creative and critical thinkers, problem solvers and active and responsible citizens equipped for lifelong learning."⁷

The Tirana Communiqué 2024 corroborates this and specifies the methods (flexible learning pathways, recognition of knowledge and competences acquired (mostly outside of university), micro-credentials) that universities can use to offer lifelong learning opportunities according to academic standards to a large number of people.⁸

In view of this, the University for Continuing Education Krems supports the flagship projects of the European Strategy for Universities through its "Erasmus Policy Statement"⁹ and its current key strategy. The future of European academic continuing education is particularly being developed through EU.ACE (European University for Academic Continuing Education)¹⁰, together with European partner universities from currently ten countries, including Switzerland and Bosnia and Herzegovina, with a focus on supplementing the Bologna Process with a fourth pillar dedicated specifically to academic continuing education and lifelong learning at university level.

As lead coordinator of the EU.ACE partnership, the University for Continuing Education Krems also maintains and promotes exchange with other European alliances in order to make an even better joint contribution to achieving the goals of improving the international competitiveness of European universities, promoting European values and identity and thus advancing the further development of the European Higher Education Area.

The University for Continuing Education Krems also supports the implementation of the European Skills Agenda (Pact for Skills) with its range of study programs and participates in the "Skills Partnership for the European Health Industry" via the European Institute of Innovation & Technology (EIT) Health. This partnership aims to address challenges of the healthcare sector, develop a European model for the future, attract new talent and support current workforce through academic continuing education.

Since 2021, the University for Continuing Education Krems has also been a member of the European University Association (EUA), Europe's largest university association, and its Council for Doctoral Education (EUA-CDE). Within the European Higher Education Area, the university is also an institutional member of the European University Continuing Education Network (EUCEN), the European Society for Research on the Education of Adults (ESREA), and the University Network for Social Responsibility.

The university makes extensive use of opportunities to participate in calls for proposals in the EU research and innovation framework program, Horizon Europe, and in the Erasmus+ program in order to strengthen its research and international cooperation. It promotes the exchange of knowledge and expertise through increased cooperation with leading international universities and research institutions. By participating in missions and EU partnerships (e.g. EIT Health, Pact for Skills) and the European Research Council (ERC), the University for Continuing Education Krems can position its research strengths in Europe and build further international cross-sector networks to promote innovation.

1.3 GLOBAL

At the University for Continuing Education Krems, global learning and global engagement are supported through numerous international mobility, cooperation, and research projects in order to ensure access to high-quality education to all individuals while taking into account diversity and inclusion. This promotes awareness of worldwide cultural pluralism within society and makes individual responsibility in a global context more visible. The university shares this contribution on an international level and in consideration of the values of the Magna Charta Universitatum 2020¹¹ with:

- students, including the international students (26%)¹²,
- universities in the ASEA-Uninet¹³, Eurasia-Pacific Uninet¹⁴ and Africa UniNet¹⁵ networks,
- partner universities outside the EU (in Bosnia and Herzegovina, China, India, Israel, Japan, Kosovo, Singapore, Switzerland, Turkey, Ukraine and the USA)¹⁶.

2 Target groups and stakeholders

The target groups of the proposed measures for implementing the key strategy are the employees and students of the University for Continuing Education Krems:

- academic and administrative staff,
- students in continuing education programs and exchange students.

The stakeholders addressed in the fields of action correspond to the university's Organizational Chart:

- Faculties
- Departments
- Centers
- Research Labs
- University administration.

3 Methodology

The update of the key strategy "Expansion of international activities" is based on the evaluation of its implementation in the period 2021–2023. The evaluation resulted in proposals for additions and corrections to the original key strategy, which were formulated to further promote the implementation of internationalization measures. The following proposals were identified in the respective fields of action:

- Field of action: Geographic dimension
 - Suggestion of a revision of the geographical focus zones, which provide orientation for future partnerships and at the same time enable bottom-up activities to reflect the current state of developments at the university;
 - Encouragement to add measures for responsible handling of partnership requests from countries and regions where EU values are not in focus.
- Field of action: Curricular and extracurricular mobility
 - Proposal of measures to add international activities in curricula (incl. study trips).
- Field of action: Inclusion and diversity
 - Suggestion of measures to include international activities (e.g. stays abroad) to career development talks;
 - Encouragement to add measures to involve students in the planning of mobility projects.
- Field of action: Digitalization
 - Proposal of measures to involve the Division of Teaching Development and Digital Transformation in the ESCI project (European Student Card Initiative).

The Service Center for International Relations has incorporated these suggestions for additions and corrections into the draft of the updated key strategy and coordinated them with the Rectorate.

4 Fields of action

4.1 GEOGRAPHICAL DIMENSION

At the end of 2023, the university had a network of 64 bilateral partner agreements (26 Memoranda of Understanding and 38 inter-institutional agreements; 58 of these in the European Higher Education Area and 6 worldwide).¹⁷ In April 2024, central bilateral Memoranda of Understanding and inter-institutional partnership agreements with partner universities, i.e. those that can be used by the entire university or an entire faculty, cover the following countries:

- EU: Germany, Denmark, Estonia, Finland, France, Greece, Ireland, Italy, Lithuania, Netherlands, Portugal, Poland, Romania, Slovakia, Slovenia, Spain, Czech Republic, Hungary, and Cyprus
- Non-EU European Higher Education Area: Bosnia and Herzegovina, Kosovo, Switzerland, Turkey, and Ukraine
- Asia: China, India, Israel, Japan, and Singapore
- North America: USA.

In addition, network-memberships enable activities and projects in the following regions:

- ASEA-UNINET: Southeast Asia
- Africa-UniNet: Africa
- Eurasia-Pacific Uninet: East, Central and South Asia, and the Pacific region.

Hence, the following strategic geographical, but not exclusive, focus zones have been identified for the period 2024 - 2026:

- Danube Region (to continue to support existing intensive activities in the region)
- European Higher Education Area (to continue to support existing activities, particularly with regard to EU.ACE)
- North and South America (to expand activities in these regions).

In addition to the focus zones and considering the actuality of the topic of knowledge security, it should be ensured that current and future partner universities of the University for Continuing Education Krems represent similar values in international cooperation. To support the university in this respect, the development of guidelines for high-quality international partnerships is being planned.

4.2 CURRICULAR AND EXTRACURRICULAR MOBILITY

Internationalization has been included as a mandatory curricular structural element of the university's new curricula: offers for acquiring international skills must be anchored in every curriculum of a continuing education study program leading to an academic degree (bachelor's and master's study programs). These can sometimes be implemented through mobility (stays abroad). A "Toolbox: Internationalization of the curriculum – funding" has already been developed to support curriculum designers. As part of the revised key strategy "Expansion of international activities", these curricular offers, as well as extracurricular mobility, will receive increased support:

- through a focus on funded short-term mobility with a virtual element;
- via the EU.ACE partnership, especially through the partners from the Danube region (for example through joint micro-credential programs or continuing education study programs);
- as part of a central internationalization module at renowned universities in countries outside of the EU (e.g. Singapore, USA), without funding.

4.3 INTERNATIONALLY AVAILABLE RESEARCH

In its research, the University for Continuing Education Krems addresses current and future societal challenges. In the interest of transdisciplinarity, it builds bridges between basic research and application, between individual disciplines and, in its role as a public university for continuing education, bridges to societal needs. In this context, it is important to continue to support the international visibility of the university's research, particularly at the following levels:

- Continuation and expansion of the mobility grant for female early career researchers;
- Increased involvement of international visiting professors from EU.ACE partner universities and increased participation in European research and society projects (science-to-society), as well as in peer reviewed publications with EU.ACE partner universities, especially those from the Danube region;
- Participation in EU.ACE Living Labs;
- Additional participation in international networks and projects, especially within the framework of Horizon Europe, by applying for and carrying out research projects, helping to design calls for proposals and participating in the evaluation process.

4.4 INCLUSION AND DIVERSITY

The University for Continuing Education Krems is committed to broadly anchoring equality, gender, and diversity as part of fulfilling its societal objectives. An Inclusion Coordinator has already been trained and named within the Service Center for International Relations and an "Inclusive Mobility Kit" and "International Skills Certificate for Staff" have been developed at the university. These are intended to ensure the participation and inclusion of all groups (students and staff) in mobility activities. Specifically, these measures aim to promote the acquisition of professional, international and intercultural skills associated with mobility activities. Future priorities in this area are defined as follows:

- Increase in short-term student mobility and ensuring its recognition after mobility;
- Further prioritization of junior academic staff and administrative staff in mobility activities and further increase in staff teaching mobilities, which are underrepresented;
- Recognition of international staff activities as an increasingly important feature of performance and qualification agreements as well as career development talks.

4.5 DIGITALIZATION IN THE ERASMUS+ PROGRAM

Digitalization in the Erasmus+ program is significant for the future of European higher education cooperation. The digitalization of the Erasmus+ program is summarized as the "European Student Card Initiative" (ESCI). The initiative consists of two blocks:

- Digitalizing and streamlining student mobility administration processes via "Erasmus without paper" (EWP);
- Rolling out the "European Student Card" and enabling easier and faster access to campus and other services via "European student card project".¹⁸

In order to implement the goals of the initiative, the Mobility Online software solution was acquired, and an EWP Coordinator was trained and named within the Service Center for International Relations. As a result, it is possible to make interinstitutional agreements online since 2022 and incoming learning agreements since 2023. The prerequisite for this was and is the European Student Identifier (ESI), which was implemented in August 2021 through participation in eduGAIN. Further digitalization measures within the Erasmus+ program will follow according to prioritization and synergies with the ongoing digitalization of the study organization.

4.6 SDGS AND SUSTAINABILITY

The increased consideration of the SDGs is one of the key strategies in the current development plan of the University for Continuing Education Krems. At the beginning of 2023, the "Platform for Sustainable Development (SDGs)" was founded for purposes of implementing the SDGs. In this context and as a contribution from the point of view of internationalization, a "Green Mobility Kit" was developed at the university. The kit provides support for deciding on whether to travel at all and how, as well as information on how best to travel abroad using sustainable means of transport within the Erasmus+ grant program. The objective of internationalization activities in connection with sustainability concerns:

- The increased use of the Green Mobility Kit and of subsidies for environmentally friendly travel.

4.7 INTERNATIONALISATION AT HOME

Internationalization has been adopted as a mandatory curricular structural element of the university's new curricula: every continuing education study program leading to an academic degree (bachelor's and master's study programs) must include opportunities for students to acquire international skills. These can be implemented through measures of *Internationalisation at Home* or *Internationalisation at a Distance*. As part of the updated key strategy "Focused expansion of international activities," further development of these opportunities will be given increased support as follows:

- With the EU.ACE partners, particularly those in the Danube region (for example, through joint micro-credential programs and/or continuing education study programs open to international students and lecturers in Krems);
- By developing the Welcome Center to facilitate onboarding for international students and staff and to simplify temporary stays for exchange students and guests.

5.1 DEVELOPMENT OF THE GUIDELINES FOR QUALITATIVE INTERNATIONAL PARTNERSHIPS	
Field of action	Geographic dimension
Description of the measure	Development of a "Safe mobility kit" to support the university in establishing new partnerships with international partners, while taking into account the principles of responsible internationalization with regard to European values and foreign interference.
Objective	Creation of the "Safe mobility kit"

5.2 SUPPORT OF CURRICULAR AND EXTRACURRICULAR SHORT-TERM MOBILITY	
Field of action	Curricular and extracurricular mobility
Description of the measure	Networking towards (EU.ACE and renowned universities in North America and Asia) and managing mobility activities with a focus on funded short-term mobility with a virtual element and on curricular mobility.
Objective	Ideally funded, high-quality stays abroad for continuing education students

5.3 STRENGTHENING AND INTERNATIONAL VISIBILITY OF RESEARCH	
Field of action	Internationally available research
Description of the measure	Networking towards Living Labs, European research and societal projects, publications, guest professors and activities for junior scientists with a focus on EU.ACE.
Objective	Securing a sustainable financing structure for the further development of EU.ACE and thus research at a high international level

5.4 INCLUSION AND DIVERSITY IN STUDENT MOBILITY ACTIVITIES	
Field of action	Inclusion and diversity
Description of the measure	Networking with a focus on EU.ACE partners for Erasmus+-funded joint modules, micro- credential programs and continuing education study programs that have been developed with student needs in mind. This makes it easier to identify study opportunities available abroad while recognition of credits completed abroad can be carried out in an uncomplicated manner. In this way, several groups of students are addressed.
Objective	Further increase in outgoing students

5.5 INCLUSION AND DIVERSITY IN STAFF MOBILITY ACTIVITIES	
Field of action	Inclusion and diversity
Description of the measure	Networking towards the mobility of junior academic staff, administrative staff and of teaching staff, with a focus on EU.ACE partners while expanding the recognition procedure for inter- national staff activities.
Objective	Increase in the number of stays abroad for junior academic staff, administrative staff and in mobility activities for teaching

5.6 DIGITALIZATION IN THE ERASMUS+ PROGRAM	
Field of action	Digitalization in the Erasmus+ program
Description of the measure	Further digitalization measures as part of the Erasmus+ program, such as digital transcripts of records, will follow according to prioritization and while maintaining synergies with the ongoing digitalization of the study organization.
Objective	Timely implementation of the mandatory digitalization steps within the Erasmus+ program

5.7 ENVIRONMENTALLY FRIENDLY STAYS ABROAD	
Field of action	SDGs and sustainability
Description of the measure	Increased promotion of the Green Mobility Kit in preparatory talks for stays abroad by students and staff, including presentation of the Erasmus+ grants for the use of sustainable means of transport.
Objective	Reducing the environmental footprint of students and staff when traveling abroad

5.8 CONTINUATION OF THE WELCOME CENTER	
Field of action	Internationalisation at Home
Description of the measure	Continuation of the Welcome Center to facilitate onboarding for international students and staff and the temporary stay for exchange students and guests, with a focus on information on arrival and stay in Krems.
Objective	Further increase in incoming students and guests
