In the data economy, businesses have large amounts of data available that enable them to make data-based decisions, to develop new business models and to rethink innovation processes. This applies not only to tech companies, but increasingly to SMEs and start-ups. Automated systems like AI are used to prepare or make business decisions on the basis of data or in the context of innovation processes. With this development, various legal issues arise. The continuing education study program

In the context of the increasing importance of data in the economy, the LL.M. on Data Economy Law was created within an Erasmus+ strategic partnership of four EU universities – University for Continuing Education Krems (Krems, Austria), Georg August University Göttingen (Göttingen, Germany), Masaryk University (Brno, Czech Republic) and Kazimieras Simonavicius University (Vilnius, Lithuania).

The continuing education study program covers potentials, challenges and (legal and societal) risks of data-driven management and data-oriented business models. Knowledge will be provided on the legal, societal, technical and organizational dimension and on how to implement data-driven management and business practices in order to avoid risks and drawbacks. Legal modules will especially cover IT-and IP-Law, Data Law, Privacy and Data Protection, Trade Secrets, Competition Law and Transnational Business Law.

- > develop strategies for dealing with intangible assets in companies;
- > create legal solutions for regulatory hurdles in the area of the data economy;
- > plan the implementation of digital business models in companies;
- > assess international risks of data-oriented business models.
